## INTRODUCTION

Admissions to the Bachelor of Design (BDes) programmes at IIT Bombay, IIT Delhi, IIT Guwahati, IIT Hyderabad, IIT Indore, IIT Roorkee and IIITDM Jabalpur are done through the Undergraduate Common Entrance Exam for Design (UCEED). Many institutes also recognize the UCEED Score Card for admissions to their BDes program. The list of result sharing institutes using UCEED scores for admissions to their BDes program is available on the official UCEED website ([www.uceed.iitb.ac.in](http://www.uceed.iitb.ac.in)).

UCEED and BDes admissions are two different activities; candidates are advised to read this complete document carefully.

Only those students who have passed Class XII (or equivalent) in the year 2025 or are appearing in the year 2026, in ANY STREAM (Science, Commerce, or Arts & Humanities) for the first time are eligible to appear for the UCEED 2026 [See **ELIGIBILITY CRITERIA FOR APPEARING IN UCEED** for complete details].

Part 1 of this brochure provides information related to UCEED 2026.

Part 2 provides information on the subsequent joint seat allocation for BDes admissions in the six participating institutes for the Academic Year 2026–2027.

Part 3 provides formats for various certificates.



# PART 1: UCEED 2026

## 1. GENERAL INFORMATION

UCEED 2026 will be conducted by the Indian Institute of Technology Bombay under the guidance of the UCEED-CEED Implementation Committee 2026 (henceforth referred to as the UCI Committee).

UCEED 2026 is open to all nationals (Indian/Foreign). Candidates seeking admission to the Bachelor's Degree programme in Design (BDes) at Indian Institute of Technology Bombay (IITB), Indian Institute of Technology Delhi (IITD), Indian Institute of Technology Guwahati (IITG), Indian Institute of Technology Hyderabad (IITH), Indian Institute of Technology Indore (IITI), Indian Institute of Technology Roorkee (IITR) and Indian Institute of Information Technology Design and Manufacturing Jabalpur (IIITDMJ), must appear for UCEED 2026.

Candidates should note that the mere appearance in UCEED 2026 or being in the rank list neither guarantees nor provides any automatic entitlement to admission to the BDes programmes of the participating institutes. UCEED 2026 qualified candidates MUST apply separately for BDes admissions as per the prescribed procedure described in Part 2 of this Information Brochure through the joint seat allocation process.

UCEED 2026 score is valid only for admission to the programmes in the academic year 2026-2027. The UCEED 2026 Score Card cannot be treated as a proof of date of birth, category or disability status.

In all matters concerning UCEED 2026 and/or the interpretation of the provisions on any matter not covered in this Information Brochure, the decision of the UCI Committee will be final and binding on all the applicants.

Although UCEED 2026 is held at different centres across the country, the Indian Institute of Technology Bombay is the Organizing Institute responsible for conducting UCEED 2026. In case of any claims or disputes arising regarding UCEED 2026, it is made clear that the High Court of Bombay alone shall have exclusive jurisdiction to entertain and settle any such claims and disputes.

## 2. THE INSTITUTES

### Indian Institute of Technology Bombay: The Organizing Institute

Indian Institute of Technology Bombay is an institution of national importance established through an Act of Parliament to foster excellence in education. The institute is recognised worldwide as a leader in the field of education and research. Reputed for the outstanding calibre of students graduating from its undergraduate and postgraduate programmes, the institute attracts the best students from the country for its Bachelor's, Master's and Doctoral programmes. Research and academic programmes at IIT Bombay are driven by faculty members who are reputed for their research contributions internationally.

## 2.1. IDC School of Design, IIT Bombay

IDC School of Design (IDC), previously known as the Industrial Design Centre at IIT Bombay, has a Bachelor of Design (BDes) programme that started in 2015. IDC now offers a four-year / eight-semester BDes programme and a five-year / ten-semester dual degree BDes + MDes programme. Students are admitted to the BDes programme after completing class XII by qualifying through the Undergraduate Common Entrance Exam for Design (UCEED). The option of shifting to a dual degree programme is available to the students at the end of their 3rd year. Both programmes are credit-based and thus offer the flexibility to progress at one's own pace. A minimum level of performance is essential for satisfactory progress. The medium of instruction is English.

The BDes programme in IDC emphasises skill-based components in the fundamentals of design in the first two years. In the third year, the students have a choice of a large number of elective courses that provide an opportunity to specialize in the various areas of design that IDC is known for. The potential for design lies in solving real-world problems. A series of design projects (one in each semester), often enriched through field trips and real-world experiences, enables students to engage with design issues and develop an understanding of design methodology. In the last two semesters of the BDes programme, the students do semester-long degree projects that demonstrate the abilities that they have acquired.

The IDC School of Design provides a conducive environment for design research, academics and collaborative projects. Supported by the excellent facilities, technical expertise and academic diversity of IIT Bombay, IDC has been involved with impactful design and research projects of national importance. Apart from the BDes and BDes + MDes programmes, IDC has well-established Master of Design (MDes) degree programmes in Industrial Design, Communication Design, Animation Design, Interaction Design, and Mobility and Vehicle Design, as well as a popular PhD programme.

Students admitted to the BDes programme are not eligible for branch change to any other undergraduate programme(s) offered by IIT Bombay at any time during the entire duration of the programme.

## 2.2. Department of Design, IIT Delhi

The Department of Design (DoD) at the Indian Institute of Technology Delhi is a centre of excellence dedicated to advancing knowledge, practice, and innovation in design. Established with the vision of integrating design thinking with science, technology, and the humanities, the department fosters a multidisciplinary approach to address contemporary challenges and create impactful solutions. The Department's diverse faculty pool addresses the learners' interests, viewpoints and expectations. The host city, the capital of India, Delhi, offers a unique locational advantage to the learners on campus to collaborate with critical actors in society, institutions and industry. The department currently offers B.Des, B.Tech in Design, M.Des, and Ph.D programs.

The B.Des. program is an eight-semester (four-year) program that provides a strong foundation in design principles, methods, and technologies, fostering creativity and human-centred thinking. Students engage in studio-based learning and multidisciplinary collaborations, preparing them for careers in diverse sectors of design and innovation.

The B.Tech in design is a unique program that combines a robust engineering curriculum with design education, enabling students to apply computational, analytical, and creative approaches to complex problems. It also has eight semesters (four years), a few courses of which are common with other engineering programs, a few with the B.Des program and other courses are dedicated to the B.Tech students. For the B.Tech in Design program, the intake is based on JEE-Advanced ranking. However, the aspirants should have qualified UCEED in the same year.

The M.Des. programme is a two-year full-time program at IIT Delhi that nurtures advanced design practitioners and researchers through a rigorous blend of theory, studio practice and interdisciplinary projects. It emphasises innovation, critical inquiry, and real-world problem solving across domains such as product, communication, interaction and systems design.

### **2.3. Department of Design, IIT Guwahati**

The Department of Design (DoD) at IIT Guwahati was set up with a vision to enkindle in some of the brightest technical minds of the country, a passion for innovation in technology driven by firm understanding, appreciation and celebration of design.

The department offers a BDes degree, MDes-Design, M.Des-EPD degrees and a Ph.D. degree. The focus of the program is on the study, invention, and creative use of technologies to create effective, usable, enjoyable experiences with technology through interdisciplinary research in engineering, design, behavioural and social sciences and to understand the impact of technology on individuals, groups, and organizations. The department envisions producing successful graduates who will be capable of leading the changing scenarios of today and tomorrow through thought, innovation, and values. ## 2.4. Department of Design, IIT Hyderabad

The Department of Design at IIT Hyderabad was established in the year 2014 with MDes degree and PhD degree. BDes programme started in the year 2019. The department offers a vibrant environment for learning, practising and exploring several facets of design. The department envisions to creatively engaging in the space between technologies and people. This involves facilitating innovation in key emergent areas such as Participatory and Collaborative Design, Ethics, Sustainability, Product Systems and Services, Design and Education, Wellness, and Crowd-sourced Design, etc.

The BDes course curriculum is designed to tackle an increasing need and demand both with the academic and the professional aspects of the discipline for undergraduate programs in Design. The BDes curriculum has a four-level structure leading to a gradual movement from general, foundational courses at level 1 to more specialized inputs at level 4. The program attempts to constitute both the 'general' dimension of design (breadth) and the specific dimensions (depth) through the four-level structure, which allows gradual focus areas to emerge. As the student moves upwards from level 1 to level 2, the student graduates to choosing between courses which offer different kinds of skills from soft to hard. The courses at level 1 would help the students to choose the mix of skills they prefer to acquire. At level 3, it is hoped that the student is ready to fine tune a certain mix or a set of skills into a specialization. It is at this stage that the specializations emerge – Product Design, Visual design, Interaction Design, User Experience Design, Film and Animation, and so on. At Level 4, the student employs all that has been gained regarding skills and understanding and applies or uses them in independent projects. Level 4 is purely about design as a *practice*. ## 2.5. School of innovation, IIT Indore

The first School of Innovation (SoI) among the IITs, SoI has been established to engage itself on creating value through innovation and providing complete solutions to urgent social problems in identified priority areas. The areas have been chosen from National Priorities and those in Mission Mode with the objective of making impact through designing the complete eco-system of the product, and ensuring its implementation on a national scale.

School of Innovation at IITI is seen as an Interdisciplinary and Collaborative Research Environment, making full use of the faculty expertise and capabilities present in various Departments of IITI. Teams have been built around identified key problems and themes; and the area of expertise available across various departments, leading to a constant stream of innovations and design solutions in the identified area of focus.

Four major areas of focus have been chosen based on urgent unmet needs, and areas of specialization already available in IIT Indore: Urban System Innovation, Educational Technologies, Healthcare Systems, and Sustainable Energy Systems. More areas specializations such as Digital Media Innovation are under planning.

**Academic Program:** The School of Innovation has started with a four-year B.Des. program with the first batch of students having joined in 2025. The first year of the B.Des. program is of Foundation Studies common to all students. From the Second Year, the students have to choose from one of the four areas of specialization being offered to begin with. From third semester onwards, every semester has common courses required for innovation design competence building, while electives are from the areas of specialization. A project component, from the chosen area of specialization, is part of every semester.

A two-year M.Des. program and a PhD program is expected to start from 2027.

**Internship and Placement:** Being a new program, a promotion program has been initiated for placing the graduating students in industry after completion of their program. Awareness building to attract potential employers which are seen as Consulting Organizations, Planning Bodies, and various Ministries at National and State levels; and efforts to find sponsors for all selected candidates is already underway.

**Research & Practice:** Basic Research into Innovation and Innovation Management will be an integral part of the activities of the School of Innovation. Undertaking Sponsored Research and Consultancy Projects including Technology Development, Conducting Field Pilots and Final Technology Transfer packages for implementation in field, is also part of the objectives.

## 2.6. Department of Design, IIT Roorkee

The institute ranks among the best technical institutes in the world and has contributed to all sectors of technological development. The institute has also been considered as a trendsetter in the area of education and research, specifically in the fields of science, technology, engineering and architecture.

Innovative design is considered one of the key drivers of success in a competitive business environment. Design education, especially focused on 'Industrial Design' has a strong potential to accelerate the process of product conceptualization, design, prototyping, and development, leading to organizational success. The Department of Design (DoD) at IIT Roorkee has been established to provide quality education focusing on innovation and design and to provide design-based solutions to the industries and society. At present, the department offers four-year Bachelor of Design (B. Des.), two-year Master of Design (M. Des.) and Ph. D. programs. It aims to provide an engaging environment to foster creativity and skills through an interdisciplinary process of teaching and training. The teaching-learning pedagogy is designed to train and develop professionals who can challenge existing designs, collaborate, and create functional, usable, user-friendly, and sustainable products. The vision of the Department of Design at IIT Roorkee is to evolve as a unique entity focusing on design and innovation culture, based on human-environmental engagement in collaborative partnerships with society, industry, and other stakeholders.

The curriculum for the eight-semester B. Des. program is designed with a unique fusion of creative thinking, design, computing, engineering and manufacturing to create a talent pool that can address industrial challenges and complex societal needs. The program envisages to develop students' competence in product design, material and manufacturing, ergonomics, user experience design, interaction design, visual design, craft and material exploration and sustainability by creatively engaging students through classroom teaching and hands-on experience. The program's unique feature is an integration of theory components with practical engagements.

Students admitted to the B. Des. programme are not eligible for branch change to any other undergraduate programme(s) offered by IIT Roorkee at any time during the entire duration of the programme.

## 2.7. Design Discipline, IIITDM Jabalpur

The Design Discipline at PDPM Indian Institute of Information Technology, Design and Manufacturing, Jabalpur offers a "holistic" design program. The discipline offers a four-year-Bachelor- of Design (BDes) two-year Master of Design (MDes) and PhD in Design programmes. The curriculum is a unique blend of design and technology so as to ensure that they are well equipped when they finally graduate from the Institute. The uniqueness of the curriculum is that, all the students have to mandatorily learn different areas of design in the initial semesters. In the advanced semesters, students are given a choice to choose electives mainly in three major domains: product, space and communication design. The students have the liberty to pursue Bachelor's / Master's thesis in their domain of interest. Thus, the students graduating from the discipline have a good understanding of different facets of design, different technologies related to design and at the same time specialize along one of the major domains namely product, space or communication design, giving them an advantage of convenient and efficient switches from one domain to another.

### 3. SCHEDULE OF UCEED 2026

UCEED is a test centre-based examination and has two parts: Part-A is computer-based and Part-B contains questions related to sketching that needs to be attempted on the provided sheet. It is compulsory for the candidates to attempt both the parts in the given time.

The total time for the examination (that includes both Part-A and Part-B) is THREE hours and it will be held as per the following schedule (any request for change in the examination date and time will not be considered):

## 4. CITIES WHERE UCEED 2026 WILL BE HELD

UCEED 2026 will be held only in the following 27 cities in India:

Ahmedabad, Bengaluru, Bhopal, Bhubaneswar, Chandigarh/Mohali, Chennai, Coimbatore, Dehradun, Delhi, Ernakulam, Guwahati, Hubballi (Hubli), Hyderabad, Jaipur, Kolkata, Kozhikode, Lucknow, Mumbai, Nagpur, Noida, Panaji, Patna, Pune, Raipur, Thiruvananthapuram, Thrissur, and Visakhapatnam.

Candidates should compulsorily opt for THREE cities of their choice, in the order of preference, at the time of online registration. Once the registration is complete, a request for a city change will NOT be entertained.

Suppose a sufficient number of candidates are not available in a listed city, such a city may be dropped from the final list, and those candidates will be allotted a centre in the city of either their second or third preference. Additionally, because of operational contingencies, the UCI Committee reserves the right to add a new city/town or remove an existing one and allot a city/town that may not be among the preferences stated by a candidate.

Candidates must make their own arrangements for appearing at the allotted centre.

**NOTE: A request for a change of examination centre will NOT be entertained after the registration is complete.**

## 5. INFORMATION ON SEATS FOR FOREIGN NATIONALS

Candidates who are NOT citizens of India at the time of registration for UCEED 2026 (by birth or naturalization) are treated as foreign nationals. Seats allotted to foreign nationals are supernumerary, with a cap of 10% of the total available seats in the program, in the order of merit. The availability of supernumerary seats will be announced at the time of seat allocation.

Foreign nationals holding OCI/PIO cards issued BEFORE 4<sup>th</sup> March 2021 will be considered for the seats in the OPEN category [see [RESERVATION POLICY](#) in the following section for details].

Foreign Nationals holding OCI/PIO cards issued ON or AFTER 4<sup>th</sup> March 2021 will be considered only for foreign supernumerary seats with a cap of 10% of the total available seats in each program.

Qualifying in UCEED 2026 is a must for all candidates to apply for admission to the BDes programmes at IIT Bombay, IIT Delhi, IIT Guwahati, IIT Hyderabad, IIT Indore, IIT Roorkee and IIITDM Jabalpur.

## 6. RESERVATION POLICY

Indian nationals belonging to certain categories are admitted under the seats reserved for them in accordance with the rules prescribed by the Government of India. The categories and the extent of reservation are as follows:

- 6.1** General category belonging to Economically Weaker Section (GEN-EWS) – 10% of seats in every course. The benefit of reservation will be given only to those General category candidates who satisfy the conditions given in the OM No. 20013/01/2018-BC-II dated January 17, 2019 issued by the Ministry of Social Justice and Empowerment.
  - The criteria for GEN-EWS will be as per the prevailing norms and/or notifications of the Government of India.
  - EWS certificates issued only on or after April 1, 2025, are accepted for the examination.
- 6.2** Other Backward Classes belonging to the Non-Creamy Layer (OBC-NCL) – 27% of seats in every course.
  - OBCs should be listed in the current updated central list of OBCs (<http://www.ncbc.nic.in>).
  - OBCs present in the state list but not covered in the central list of OBCs (as per the list in <http://www.ncbc.nic.in>) are NOT eligible to claim the reservation.
  - The criteria for Non-Creamy Layer (OBC-NCL) will be as per the notification of Government of India. OBC-NCL certificates issued only on or after April 1, 2025, are accepted for the examination.
- 6.3** Candidates belonging to the creamy layer of OBC are NOT entitled to reservation. Such candidates are treated as belonging to the general (GEN), i.e. unreserved category, and they will be eligible only for the OPEN seats – the seats for which all candidates are eligible.
- 6.4** Scheduled Caste (SC) – 15% of seats in every course.
- 6.5** Scheduled Tribe (ST) – 7.5% of seats in every course.
- 6.6** The benefit of reservation will be given only to those castes and tribes that are mentioned in the respective central list of corresponding states published by the Government of India (websites: <https://socialjustice.gov.in> and <https://ncst.nic.in>).
- 6.7** Persons with Disability (PWD) – 5% seats in each of OPEN, GEN-EWS, OBC-NCL, SC, and ST category seats.

- Candidates with at least 40% impairment irrespective of the type of disability i.e., locomotor, visual or SEVERE dyslexic shall be eligible for the benefits of PwD sub-category.
- Leprosy-cured candidates who are otherwise fit to pursue the courses are also included in this sub-category.

**6.8** Candidates belonging to the GEN-EWS, OBC-NCL, SC, ST, and PwD categories/sub-categories will be declared as qualified on the basis of a relaxed criterion [see **EVALUATION**].

**6.9** The category of a candidate as entered in the database will be final and shall remain the same in UCEED 2026 examination. Requests for change of category will NOT be entertained.

**6.10** Seats remaining vacant under the SC, ST, EWS, and OBC-NCL categories shall NOT be allotted to candidates belonging to other categories.

**6.11** Candidates must note that the benefit of reservation will be given to them subject to verification of documents. If it is discovered at any stage that a candidate has used a false / fake / incorrect document, or has furnished false, incorrect or incomplete information, in order to avail the benefit of reservation, then such a candidate shall be excluded from all admission processes. In case such a candidate has already been given admission, the admission shall stand cancelled.

## Foreign Nationals

**6.12** Candidates who are **NOT** citizens of India (by birth or naturalized) (but not OCI/PIO candidates) shall be considered as foreign nationals. Seats allotted to such foreign national candidates are supernumerary with a cap of 10% of total number of seats in every course. These candidates are outside the ambit of reservation of seats under the GEN-EWS, OBC-NCL, SC, ST, and PwD categories / sub-categories, as specified herein. There are no separate supernumerary seats or sub-category for females in the foreign national supernumerary seats.

**6.13** To be considered for seat allocation, foreign national candidates should have an All India Rank (AIR) and satisfy all the eligibility requirements meant for an OPEN category candidate. Seat allocation to foreign national candidates is carried out after the completion of seat allocation to all the Indian national candidates (in the same round). A seat in an institute will be allotted to a foreign national candidate if their rank is the same or better than the closing rank of the

OPEN category candidate in that academic programme, subject to the 10% cap on seats mentioned above, in the order of merit.

**OCI/PIO Candidates:**

- 6.14** At the time of seat allocation, the candidates with OCI/PIO cards issued BEFORE 4th March 2021 will be considered for the seats in the OPEN category as per the judgement passed by the Hon'ble Supreme Court of India concerning the Writ Petition (Civil) 891 / 2021, dated February 03, 2023. These candidates will be included in the Common Rank List and/or CRL-PwD list, and also for the Female Supernumerary seats, as applicable, subject to qualifying the UCEED 2026 exam. The OCI/PIO candidates are not entitled to the benefit of reservation under the GEN-EWS, OBC-NCL, SC or ST categories for the allocation of seats.
- 6.15** The candidates with OCI/PIO cards issued ON or AFTER 4th March 2021 will be treated as foreign nationals and eligible only for foreign supernumerary seats.
- 6.16** Identity Proof: Identity proof of the candidate is required in the form of a Citizenship Certificate/Foreign Passport and/or OCI/PIO Card, where applicable.
- 6.17** If it is discovered at any stage that a candidate has used a false / fake / incorrect document, or has furnished false, incorrect or incomplete information, in order to avail the benefit applicable to the OCI/PIO card holders, then such a candidate shall be excluded from all admission processes. In case such a candidate has already been given admission, the admission shall stand cancelled.
- 6.18** Note that there will be no spot admission rounds in IITs (Indian Institutes of Technology), after completing the counselling. IIITDM Jabalpur (Indian Institute of Information Technology, Design and Manufacturing) may conduct a spot round of admissions at the institutional level if there are any vacant seats after completion of the counselling.

## **7. ELIGIBILITY CRITERIA FOR APPEARING IN UCEED 2026**

A candidate, including a foreign national, must simultaneously fulfil every one of the following three criteria to appear in UCEED 2026.

### **Criterion 1 - Age limit:**

The candidate should have been born on or after October 1, 2001, if belonging to the OPEN/EWS/OBC-NCL category and born on or after October 1, 1996, if belonging to the SC, ST or PwD category.

### **Criterion 2 - Number of attempts:**

A candidate can attempt UCEED a maximum of two times, and that too in consecutive years. Note that the UCEED score is valid for one year and only for admissions in the same corresponding academic year.

### **Criterion 3 - Qualifying examination:**

- (i) A candidate should have appeared for the Class **XII** (or equivalent) examination for the first time in either 2025 OR 2026 to be eligible for attempting UCEED 2026. Students from ALL STREAMS (Science, Commerce, and Arts & Humanities) are eligible.
- (ii) Those who appeared for the first time in their qualifying examination (Class **XII**) in 2024\* or earlier are NOT eligible to appear in UCEED 2026.

\* By appearance in Class XII (or equivalent) examination, it is meant that the Board concerned declared the result for that year irrespective of whether or not examination was conducted. It will be considered as an appearance even if the result of a particular candidate got withheld.

However, if the examination Board of Class XII (or equivalent) declared the results for the academic year 2023-24 on or after September 30, 2024, then the candidates of that Board who appeared for their Class XII (or equivalent) examination in 2024 are also eligible to appear in UCEED 2026, provided they meet all the other eligibility criteria. In case the examination Board of Class XII (or equivalent) declared the results for the academic year 2023-24 before September 30, 2024 but the result of a particular candidate was withheld for whatever reason, then the candidate will not be eligible to appear in UCEED 2026.

## 8. QUALIFYING EXAMINATION

- Final examination of the 10+2 system, conducted by a Central or State Board recognized by the Association of Indian Universities.
- Intermediate or two-year Pre-University examination conducted by a Board or University recognized by the Association of Indian Universities ([www.aiu.ac.in](http://www.aiu.ac.in)).
- Final examination of the two-year course of the Joint Services Wing of the National Defence Academy.
- Senior Secondary School Examination conducted by the National Institute of Open Schooling with a minimum of five subjects.
- Any Public School, Board or University examination in India or a foreign country recognized as equivalent to the 10+2 system by the Association of Indian Universities (AIU).
- H.S.C. vocational examination.
- General Certificate of Education (GCE) examination (London, Cambridge or Sri Lanka) at the Advanced (A) level.
- High School Certificate Examination of the Cambridge University or International Baccalaureate Diploma of the International Baccalaureate Office, Geneva.
- Candidates who have completed Class XII (or equivalent) examination outside India or from a Board not specified above should produce a certificate from the Association of Indian Universities to the effect that the examination they have passed is equivalent to the Class XII examination.
- In case the Class XII examination is not a public examination, the candidate must have already passed at least one public (Board or Pre-University) examination before appearing for UCEED.
- A Diploma recognized by the All-India Council for Technical Education ([www.aicte-india.org](http://www.aicte-india.org)) or a State Board of Technical Education of at least THREE years duration. It is important to note that the eligibility criteria of the participating Institutes may not consider candidates with a Diploma of three-year duration.

## 9. REGISTRATION FOR UCEED 2026

- 9.1 Candidates should register for appearing in UCEED 2026. Registration can be done ONLY through the online registration portal linked from [www.uceed.iitb.ac.in](http://www.uceed.iitb.ac.in)
- 9.2 Candidates should simultaneously satisfy ALL the THREE eligibility criteria [Refer [ELIGIBILITY CRITERIA FOR APPEARING IN UCEED 2026](#)].
- 9.3 Registration will be cancelled if, at a later date, it is found that the candidate does NOT meet any of the three eligibility criteria.
- 9.4 Registration fee is NEITHER refundable NOR transferable.
- 9.5 It will be the sole responsibility of the candidate to provide the correct information regarding the qualifying exam and category, and upload the VALID documents in the required formats in the registration form. Registration forms, incomplete in any way, will be summarily rejected and the registration will be considered invalid.
- 9.6 The admitting institutes have the right to cancel, at any stage, the admission of a candidate in accordance with their rules and regulations in force, if it is found that any information provided by the candidate is incorrect or the registration is incomplete.

Detailed instructions for the online registration are provided on the registration portal.

- The above registration fee is applicable till the closing date of October 31, 2025.
- A late fee of ₹ 500/US \$ 50 is applicable to candidates registering after the closing date of October 31, 2025, and till the late registration closing date, i.e., November 07, 2025, (5:00 pm). It is not possible to register after 5:00 pm on November 07, 2025, as the online registration portal will close automatically. - Detailed instructions related to the payment of registration fee will be available on the online registration portal.

## 11. SERVICES OF A SCRIBE AND COMPENSATORY TIME

The services of a scribe (amanuensis) are available to candidates who have a disability and require assistance in operating the computer for Part-A of the examination. However, the candidate will be required to attempt Part-B without the assistance of a scribe due to the nature of the paper. The rules for the same are described below:

- 11.1** To avail of this benefit, the candidate should select this option in the online registration form AND upload a copy of the PwD certificate (Appendices 5 – 9) at the time of online registration for UCEED 2026.
- 11.2** In case of persons with disabilities in the category of blindness, locomotor disability (Both Arms only) and cerebral palsy, the facility of scribe/reader/ lab assistant may be given, if so desired by the person, upon production of valid disability certificate/ UDID card **without** requiring an additional medical certificate as per the proforma given in Appendix 10.
- 11.3** In the case of disabilities **other than** blindness, locomotor disability (both arms affected only), and cerebral palsy, the facility of scribe/reader/lab assistant must be allowed on production of a certificate to the effect that the person concerned has a functional limitation to write, caused by the specified disability and, therefore, a scribe is essential to write the examination on his/her behalf. The certificate is to be issued, after due medical examination by the Chief Medical Officer/Civil Surgeon/ Medical Superintendent of a Government healthcare institution as per the proforma given in Appendix 10.
- 11.4** The eligible candidates will receive a compensatory time of 20 minutes per hour in Part A and 20 minutes for Part B. The compensatory time for Part-A cannot be transferred to Part-B and vice versa.
- 11.5** If a PwD candidate wants to avail compensatory time (20 minutes per hour) and/or request the assistance of a scribe, the same request should be mentioned while filling out the registration form. PwD certificate is to be uploaded along with such requests, which will be made in the given format (Appendix 11).
- 11.6** The UCEED Office will assess the request along with the supporting document(s) and contact the candidate via email with further instructions, if necessary.
- 11.7** Necessary arrangements will be made by the examination centre to provide a panel of scribes (amanuenses) for the eligible candidates. Scribes will be students of Class XI. The PwD/Dyslexic (severe) candidate has to choose a scribe from this panel, typically a day

before the examination.. Candidates will NOT be allowed to bring their own scribes.

**11.8** If it is found that a candidate has used the services of a scribe and/or availed of compensatory time but does NOT possess the extent of disability that warrants the use of a scribe and/or compensatory time, they will be excluded from the process of evaluation, ranking and admission. If the candidate has already been admitted, their admission will be cancelled.

## 12. DOCUMENTS REQUIRED FOR REGISTRATION FOR UCEED 2026

Below is a list of certificates and other documents that must be uploaded during online registration for UCEED 2026. The certificates MUST be in the Central Government format as given in the appendices.

- A recent colour photograph of a full frontal (face) view, with the head centred in the frame covering 70–80% of the photograph and taken **within the last six months**. The photograph should be such that it allows unambiguous identification of the candidate (only JPEG image formats with file extension .jpg will be accepted).
- A clear image of the candidate's full signature on white paper (only JPEG image formats with file extension .jpg will be accepted).
- A document for the proof of age such as SSC certificate/ Passport/ Birth certificate needs to be submitted (only PDF format with the file extension .pdf will be accepted).
- Qualifying examination certificate, if appeared in 2025 (only PDF format with file extension .pdf will be accepted).
- For candidates appearing in 2026 for the Class XII exam, a certificate from the school/college Principal or the Authorized official from the Board in the given format (Appendix 1) should be uploaded (only PDF format with file extension .pdf will be accepted).
- If the name is not the same as in the Class XII certificate, a gazette notification showing the name change is required (only PDF format with file extension .pdf will be accepted).

### Candidates seeking admission under the EWS, OBC-NCL, SC, ST or PwD category

- OBC-NCL (Appendix 2), Caste (for SC), Tribe (for ST) (Appendix 3), EWS (Appendix 4) or PwD certificate (Unique Disability Identification (UDID) certificate or copy of UDID card or Forms in Appendices 5 – 7) issued by a competent authority (only PDF formats with file extension .pdf will be accepted).
- Dyslexic candidates need to submit FORM-DYSLEXIC 1 and 2 (Appendices 8 and 9) instead of PwD certificate. The certificate must mention 'SEVERE' under Dyslexia category to enable the candidate to get the benefit of PwD category.

### PwD Candidates requiring Scribe (Amanuensis) and/or Compensatory Time

- PwD candidates requiring scribe and/or compensatory time (20 minutes per hour)

during the exam need to upload a request letter (Appendix 11). Also refer to sections 11.2 and 11.3 for further details on availing the services of a scribe.

- The compensatory time for Part-A cannot be transferred to Part-B and vice versa.

**For Foreign Candidates (holders of OCI/PIO cards issued BEFORE 4th March 2021)**

- Nationality Certificate – valid Passport will be accepted.
- OCI/PIO card -OCI/PIO card issued before 4<sup>th</sup> March 2021 will be accepted

**For Foreign Candidates (holders of OCI/PIO cards issued AFTER 4th March 2021)**

- Nationality Certificate – valid *Citizenship Certificate/Foreign Passport will be accepted.*
- OCI/PIO card – valid OCI/PIO card will be accepted

NOTE: All documents and information uploaded by the candidate shall be subject to verification at a subsequent stage(s). The candidature shall be cancelled if it is found at any stage that the information or document(s) furnished by the candidate is false.

## 13. ADMIT CARD

**13.1** Candidates whose registration is complete in all aspects can download the Admit Card for UCEED 2026 from the registration portal ([www.uceed.iitb.ac.in](http://www.uceed.iitb.ac.in)) from the date specified below.

**13.2** The Admit Card will bear the following details of the candidate: Name, UCEED Registration ID, Roll Number for UCEED 2026, Date of Birth, Category, photograph, signature, examination schedule, examination centre details and instructions to candidates.

**13.3** Candidates should carefully examine ALL the entries in the Admit Card, and in case of any discrepancy, please refer to the website [www.uceed.iitb.ac.in](http://www.uceed.iitb.ac.in) for required modification, latest by January 08, 2026, 5:00 pm.

**13.4** If the Admit Card is unavailable for downloading, the candidate should contact the UCEED Office at IIT Bombay immediately via email or phone [See [CONTACT INFORMATION](#)].

**13.5** A printed copy of the downloaded Admit Card MUST be produced during the examination.

## 14. DAY OF THE EXAMINATION

**14.1 Exam date and time:** Sunday, 18 January 2026, 9.00 am - 12.00 noon.

**14.2 Reporting time:** Candidates can report at the examination centre (as allotted in the admit card) from 7:00 am on Sunday, January 18, 2026, with a printout of the Admit Card and a Valid Original Photo Identity Proof. This is required to record the biometric information (thumb impression and photograph) before appearing for the examination. The thumb impressions may be verified again at the time of admissions and therefore, it is recommended to ensure that fingerprints are clearly captured.

Entry to examination centre after the start of examination (9:00 AM) will not be permitted.

**14.3** Only candidates with valid Admit Card and an original Photo Identity Proof will be allowed inside the examination centre.

**14.4** The identity of the candidates will be verified by invigilators as well as IIT representatives. If the identity of any candidate is in doubt, the candidate may not be allowed to appear for the examination. However, at their discretion, the authorities may permit the candidate to appear for the examination after completing certain formalities. No extra time will be allowed to complete the examination instead of the time taken to complete these formalities. If candidates with doubtful identities are permitted to appear, their candidature shall be subject to the decision of UCI Committee, which shall be final and binding.

**14.5** Impersonation and/or use of any unfair means in the examination is a serious offence which will result in immediate disqualification of the candidate from UCEED and lead to criminal proceedings against the candidate.

**14.6** Candidates will NOT be allowed to carry any electronic devices (mobile phones, smart phones, watches of any type, calculators, tablets and the like), abacus, slide rule, log books, study material of any type, geometry box, and so on to the examination hall. A list of forbidden items will be put-up on the website ([www.uceed.iitb.ac.in](http://www.uceed.iitb.ac.in)) before the exam, if there are additional items.

**14.7 Drawing Materials:** Candidates must bring their own pencils in a transparent packet. Shades of black colour are permitted. However, sketch pens, color pencils, poster colors and other colouring materials are NOT permitted inside the examination hall. Candidates may bring a writing board of A4 size. Exchanging and borrowing of these materials is NOT permitted inside the examination hall.

**14.8** Candidates have to remain in the examination hall for the entire duration of the examination.

**14.9** Part-A of the examination is a computer-based test. In the event of any technical problems, candidates may approach the invigilator for assistance, and steps will be immediately taken to remedy the problem or assign a different computer terminal if required. Candidates will get the allotted time to attempt their paper even in the event of any technical problem, and the time lost due to technical problems shall be automatically adjusted in the server.

**14.10** Any request for change in the examination date and time will not be considered.

Further instructions, if any, shall be posted on the website ([www.uceed.iitb.ac.in](http://www.uceed.iitb.ac.in)) before the exam.

## 15. QUESTION PAPER

- 15.1** There will be ONE question paper of total THREE hours duration.
- 15.2** The question paper will be in English only.
- 15.3** The question paper will carry a total of **300 marks**.
- 15.4** The question paper will consist of two parts: Part-A and Part-B. It is compulsory to attempt questions from both parts.
- 15.5** Utmost care is taken to prepare an error free question paper. However, if an error is detected in the question paper, the UCI Committee shall take an appropriate decision after the examination, which shall be final.

Details of the two parts of the question paper are given below:

### **Part-A** (Total marks: **200**; Maximum time: **2 hours**)

- This part will be administered through a computer-based test.
- This part will consist of three sections.

**Section 1:** NAT (Numerical Answer Type): 14 questions (4 marks each; no negative marks). For these questions, **the answer is a number** that needs to be entered using a virtual keyboard on the computer screen. No choices will be shown for these questions.

**Section 2:** MSQ (Multiple Select Question): 15 questions. Each MSQ may **have one or more than one correct choice(s)** out of the four given. The following is the marking scheme:

**Full Marks: + 4** If only (all) the correct option(s) is(are) chosen and NONE of the incorrect options is chosen.

**Partial Marks: + 3** If all the four options are correct but ONLY three options are chosen and NONE of the incorrect options is chosen.

**Partial Marks: + 2** If three or more options are correct but ONLY two options are chosen, both of which are correct and NONE of the incorrect options is chosen.

**Partial Marks: + 1** If two or more options are correct but ONLY one option is chosen and it is a correct option and NONE of the incorrect options is chosen.

**Zero Marks: 0** If NONE of the options is chosen (i.e., the question is unanswered).

**Negative Marks: -1** In all other cases.

**Section 3:** MCQ (Multiple Choice Question): 28 questions (3 marks each for the correct answer; 0.71 negative marks for incorrect answers). Each MCQ will have four choices, out of which **only one is the correct answer**.

**Part-B** (Total marks: 100; Maximum time: 1 hour)

- Part-B consists of TWO questions to test the candidates' drawing skills and design aptitude. This will require subjective evaluation. The questions in Part-B will be displayed on the computer screen, and the answer must be written/drawn in the answer book provided by the invigilator. In the case of PwD candidates availing the use of a scribe, assistance in attempting Part-B is not permitted, as the question is aimed at evaluating their drawing skill.
- Part-B answer booklets will be collected at the end of the examination.
- Part-B questions are mandatory.
- The entire paper (Part-A and Part-B) must be finished within the stipulated time for each part.

## 16. SYLLABUS

UCEED 2026 will have two parts.

**Part-A** will have questions on the following topics:

- **Visualization and spatial reasoning:** Ability to visualise and transform 2D shapes and 3D objects and their spatial relationships.
- **Practical and scientific knowledge:** Know-how of scientific principles and everyday objects.
- **Observation and design sensitivity:** The capacity to detect concealed properties in daily life and think critically about them. Attention to detail, classification, analysis, inference and prediction.
- **Environment and society:** General awareness of environmental, social and cultural connections with design.
- **Analytical and logical reasoning:** Ability to analyse qualitative and quantitative information.
- **Language:** Proficiency in reading and comprehending Standard English.
- **Creativity:** Grasp of verbal and non-verbal analogies, metaphors, signs and symbols.

**Part-B** will have questions on the following topics:

**Drawing:** Ability to draw products, people or scenes in proportion with good line quality, composition, proportion, perspective and shading.

**Design aptitude:** Capability to practically and appropriately respond to problems/situations with ingenuity and empathy.

Note: The topics listed above are exhaustive and indicative of the nature of the questions. However, UCEED 2026 may not cover all the above mentioned topics.

## 17. EVALUATION

**17.1** Part-A of the examination is a computer-based test; there is NO scope for reviewing, re-grading or re-totalling the Part-A marks of the examination paper.

**17.2** Part-B contains two questions which expert examiners will manually evaluate. Part-B of UCEED 2026 is a subjective section, and no model solution exists. It will be evaluated holistically on the criteria given in the question.

**17.3** There is NO provision for RE-EVALUATION or RE-TOTALLING in UCEED 2026. Request for re-evaluation/re-totalling will NOT be entertained under any circumstances. No correspondence in this regard shall be entertained.

**17.4** **Shortlisting:** Marks obtained in Part-A will be used to shortlist candidates. The cut-off ( $\delta$ ) for Part-A marks to shortlist candidates in the OPEN category will be  $\mu + (\sigma/2) = \delta$ , where  $\mu$  and  $\sigma$  are the average marks and standard deviation of distribution of marks obtained by ALL the candidates in Part-A of UCEED 2026. The  $\mu$ ,  $\sigma$ , and  $\delta$  will be rounded-off to two decimal places. The candidates belonging to the reserved categories shall have to fulfil a relaxed cut-off mark, which will be  $0.9\delta$  for OBC-NCL/EWS,  $0.5\delta$  for SC/ST/PwD, where  $\delta$  is the cut-off mark for OPEN category.

**17.5** Part-B paper of those candidates who do not get shortlisted, shall not be evaluated.

**17.6** All shortlisted candidates will get a rank.

**17.7** The evaluated answer booklets of Part-B will not be shared with the candidates.

**17.8** Answer booklets of Part – B will be preserved ONLY for a period of three months from the date of declaration of the UCEED results.

**17.9** The evaluation of Part-B will be done manually by at least two expert evaluators separately and independently. Following is the scheme of evaluation for **each question** in Part-B.

- If the difference in marks awarded by the two evaluators  $\leq 10$  marks, a simple average of the two evaluations will be considered.
- If the difference  $> 10$  marks, the answer sheet of Part-B will be evaluated by a third expert examiner (and so on until the difference of marks  $\leq 10$ ).
- A simple average of the closest of two evaluations will be selected as the final marks.
- If the difference in marks of the closest of two evaluations is  $>10$  after several evaluations, a moderator will be invited to examine the answers.

- If the difference in marks between the moderator and either of the examiners is the same, then the higher average will be considered for calculating the score.

**17.10** The total UCEED score will be calculated by adding the marks obtained in Part-A and Part-B. This total score will be used to prepare the final result/rank.

**17.11** UCEED 2026 Question Paper and Draft Answer Keys of Part-A will be released on the UCEED website ([www.uceed.iitb.ac.in](http://www.uceed.iitb.ac.in)) on January 20, 2026.

**17.11.1** Any comments or objections to the draft answer key may be given only in the **candidates' portal** within a period of two days, i.e., till January 22, 2026, by 5:00 pm.

**17.11.2** The order in which a question appears may differ for each candidate. Hence, the candidates are advised to use the Master Question Paper uploaded on the official UCEED website ([www.uceed.iitb.ac.in](http://www.uceed.iitb.ac.in)) as a reference to upload their comments/queries. This would help the committee to map the candidates' comments/queries to the right question.

**17.11.3** Comments/objections sent via email or in any mode other than through the candidates' portal will not be considered.

**17.12** The candidates' responses for Part-A of UCEED 2026 will be available for download ONLY until the declaration of the UCEED results and not thereafter.

**17.13** The UCI Committee will take the final decision regarding the contested answer keys after consolidating and considering all the comments from the candidates and the paper-setting team. This decision is final and will be binding on all the candidates.

## 18. RESULTS OF UCEED 2026

- 18.1 Results will be declared on March 06, 2026.
- 18.2 UCEED results will be available only on the official website ([www.uceed.iitb.ac.in](http://www.uceed.iitb.ac.in)). Candidates must use their **user login and password** (created during registration) to view the results on the webpage.
- 18.3 All the candidates who appeared in UCEED 2026 can download their Score Card from March 10, 2026, to July 31, 2026, from the official UCEED 2026 website.
- 18.4 All shortlisted candidates will get a common merit rank (All India Rank). All shortlisted candidates are considered as qualified candidates in UCEED 2026.
- 18.5 Obtaining a rank in UCEED 2026 does NOT guarantee admission to the BDes programme. Hard copies of the UCEED Score Card will not be available. Hence, they will NOT be sent to qualified candidates by post or email.
- 18.6 The responses of the candidates for Part-A of UCEED 2026 will be available for download ONLY until the declaration of the UCEED result. Downloading of Part-A responses will be DISABLED once the UCEED results are declared. In this regard, no further requests will be entertained.
- 18.7 Digital copies of the scorecards will be maintained at the UCEED office for a maximum duration of five years from the date of issue.

*Information provided in the registration form by the UCEED candidates will be shared with the participating and result-sharing institutes.*

## 19. RANK LISTS

**19.1** All shortlisted candidates will get a rank. All shortlisted candidates are considered as qualified candidates in UCEED 2026. For details on shortlisting criteria, see 17. **EVALUATION**.

**19.2** Rank list will be prepared based on the total marks (Part-A marks and Part-B marks combined) in UCEED 2026.

**19.3** If the total marks scored by two or more candidates are the same, then the following tie-break policy will be used for awarding ranks:

- i. A higher rank will be assigned to the candidate who has obtained higher marks in Part-B.
- ii. If the criterion given in (i) does not break the tie, higher rank will be assigned to the candidate who has obtained higher marks in Section 2 of Part-A.
- iii. If the criteria (i) and (ii) do not break the tie, higher rank will be assigned to the candidate who has obtained higher marks in Section 1 of Part-A.
- iv. If there is a tie even after this, the candidates will be assigned the same rank.

## **PART 2: BDes Admissions**

## 21. ELIGIBILITY CRITERIA FOR APPLYING FOR BDes

**21.1** To apply for admission to the BDes programmes of the participating institutes, i.e., IIT Bombay, IIT Delhi, IIT Guwahati, IIT Hyderabad, IIT Indore, IIT Roorkee and IIITDM Jabalpur, an applicant is required to fulfil ALL the following three criteria simultaneously.

**Criterion 1 – Age limit:**

The candidate should have been born on or after October 1, 2001, if belonging to the OPEN/EWS/OBC-NCL category and on or after October 1, 1996, if belonging to the SC, ST or PwD category.

**Criterion 2 – UCEED qualification:**

The candidate should have qualified, i.e., obtained a rank, in UCEED 2026.

**Criterion 3 – Qualifying examination:**

The candidate should have passed all five subjects in the qualifying examination (Class XII or equivalent) in 2025 or 2026. Those who appeared for the first time in their qualifying examination in 2024 or earlier are NOT eligible.

**21.2** Candidates from the Science Stream (at 10+2 level) with Physics, Chemistry and Mathematics as subjects are eligible to apply to all the seven participating institutes (IIT Bombay, IIT Delhi, IIT Guwahati, IIT Hyderabad, IIT Indore, IIT Roorkee and IIITDM Jabalpur). Candidates from any other stream (Science without Mathematics or Physics or Chemistry, Commerce, and Arts & Humanities) are eligible to apply to IIT Bombay, IIT Delhi, IIT Hyderabad and IIT Indore.

**21.3** The following table provides the consolidated information on the eligibility of admissions to B.Des programme in the participating institutes.

**21.4** The candidates appearing for their qualifying examination (Class XII or equivalent) in 2026 should ensure the following:

(a) all parts of their final examination are completed by the date of application for admission. However, in exceptional cases where the qualifying examination is expected to be held after the date of application for admission, candidates must contact UCEED office by email addressed to [uceed@iitb.ac.in](mailto:uceed@iitb.ac.in)

(b) proof of having passed the qualifying examination with required eligibility is submitted by September 30, 2026 to the admitting institute.

**21.5** If a qualifying Examination Board awards only letter grades without providing information on the passing grade on the grade sheet, the candidate should obtain a certificate from the Board specifying the passing grade and upload it along with the grade sheet. In case such a certificate is not provided, the decision taken by the UCI Committee will be final.

**21.6** The criteria, as specified above, are applicable “in toto” to all the applicants, including foreign nationals. Seats allotted to foreign nationals are supernumerary, with a cap of 10% of the total seats in a program. Applications from foreign nationals holding OCI/PIO cards issued BEFORE 4th March 2021 are only considered under the OPEN category. They are outside the ambit of seat reservation under the EWS, OBC-NCL, SC, and ST categories.

**22.1** PwD reservations @ 5% will be horizontal. The allocation of seats in the PwD category will be displayed along with the seat matrix of academic year 2026-27.

**22.2** Candidate may refer to the final seat matrix for the academic year 2026-27 from the official UCEED 2026 website ([www.uceed.iitb.ac.in](http://www.uceed.iitb.ac.in)) at the time of application for BDes admissions.

**22.3** During the counselling process, e-mail or phone queries regarding the status of vacant seats at various institutes will NOT be entertained. All the information regarding seat allotment shall be published on the official UCEED 2026 website ([www.uceed.iitb.ac.in](http://www.uceed.iitb.ac.in)), as per the schedule.

## 23. RESERVATION OF SEATS

Indian nationals belonging to certain categories are admitted under the seats reserved for them in accordance with the rules prescribed by the Government of India. The categories and the extent of reservation are as follows:

- 23.1** General category belonging to Economically Weaker Section (GEN-EWS) – 10% of seats in every course. The benefit of reservation will be given only to those General category candidates who satisfy the conditions given in the OM No. 20013/01/2018-BC-II dated January 17, 2019 issued by the Ministry of Social Justice and Empowerment.
  - The criteria for GEN-EWS will be as per the prevailing norms and/or notifications of the Government of India.
  - EWS certificates issued only on or after April 1, 2026, are accepted for admissions to the Institutes in the academic year 2026-27.
- 23.2** Other Backward Classes belonging to the Non-Creamy Layer (OBC-NCL) – 27% of seats in every course.
  - OBCs should be listed in the current updated central list of OBCs (<http://www.ncbc.nic.in>).
  - OBCs present in the state list but not covered in the central list of OBCs (as per the list in <http://www.ncbc.nic.in>) are NOT eligible to claim the reservation.
  - The criteria for Non-Creamy Layer (OBC-NCL) will be as per the notification of Government of India. OBC-NCL certificates issued only on or after April 1, 2026, are accepted for admissions to the Institutes in the academic year 2026-27.
- 23.3** Candidates belonging to the creamy layer of OBC are NOT entitled to reservation. Such candidates are treated as belonging to the general (GEN), i.e. unreserved category, and they will be eligible only for the OPEN seats – the seats for which all candidates are eligible.
- 23.4** Scheduled Caste (SC) – 15% of seats in every course.
- 23.5** Scheduled Tribe (ST) – 7.5% of seats in every course.
- 23.6** The benefit of reservation will be given only to those castes and tribes that are mentioned in the respective central list of corresponding states published by the

Government of India (websites: <https://socialjustice.gov.in>; <https://ncst.nic.in>)

**23.7** Persons with Disability (PWD) – 5% seats in each of OPEN, GEN-EWS, OBC-NCL, SC, and ST category seats.

- Candidates with at least 40% impairment irrespective of the type of disability i.e., locomotor, visual or SEVERE dyslexic shall be eligible for the benefits of PWD sub-category.
- Leprosy-cured candidates who are otherwise fit to pursue the courses are also included in this sub-category.

**23.8** Candidates belonging to the GEN-EWS, OBC-NCL, SC, ST, and PWD categories/sub-categories will be declared as qualified on the basis of a relaxed criterion [see **section 17 (EVALUATION) in the UCEED 2026 IB on page 29**].

**23.9** The category of a candidate as entered in the database will be final and shall remain the same in UCEED 2026 examination. Requests for change of category will NOT be entertained.

**23.10** Seats remaining vacant under the SC, ST, EWS, and OBC-NCL categories shall NOT be allotted to candidates belonging to other categories.

**23.11** Candidates must note that the benefit of reservation will be given to them subject to verification of documents. If it is discovered at any stage that a candidate has used a false / fake / incorrect document, or has furnished false, incorrect or incomplete information, in order to avail the benefit of reservation, then such a candidate shall be excluded from all admission processes. In case such a candidate has already been given admission, the admission shall stand cancelled.

## Foreign Nationals

**23.12** Candidates who are NOT citizens of India (by birth or naturalized) (but not OCI/PIO candidates) shall be considered as foreign nationals. Seats allotted to such foreign national candidates are supernumerary with a cap of 10% of total number of seats in every course. These candidates are outside the ambit of reservation of seats under the GEN-EWS, OBC-NCL, SC, ST, and PWD categories / sub-categories, as specified herein. There are no separate supernumerary seats or sub-category for females in the foreign national supernumerary seats.

**23.13** To be considered for seat allocation, foreign national candidates should have an All-India Rank (AIR) and satisfy all the eligibility requirements meant for an OPEN category candidate. Seat allocation to foreign national candidates is carried out after the completion of seat allocation to all the Indian national candidates (in the same round). A seat in an institute will be allotted to a foreign national candidate if their rank is the same or better than the closing rank of the OPEN category candidate in that academic programme, subject to the 10% cap on seats mentioned above, in the order of merit.

**OCI/PIO Candidates:**

**23.14** At the time of seat allocation, the candidates with OCI/PIO cards issued BEFORE 4th March 2021 will be considered for the seats in the OPEN category as per the judgement passed by the Hon'ble Supreme Court of India concerning the Writ Petition (Civil) 891 / 2021, dated February 03, 2023. These candidates will be included in the Common Rank List and/or CRL-PwD list as applicable, subject to qualifying the UCEED 2026 exam. The OCI/PIO candidates are not entitled to the benefit of reservation under the GEN-EWS, OBC-NCL, SC or ST categories for the allocation of seats.

**23.15** The candidates with OCI/PIO cards issued On or AFTER 4th March 2021 will be treated as foreign nationals and eligible only for foreign supernumerary seats.

**Identity Proof:** Identity proof of the candidate is required in the form of a Citizenship Certificate/Foreign Passport and/or OCI/PIO Card, where applicable.

**23.16** If it is discovered at any stage that a candidate has used a false / fake / incorrect document, or has furnished false, incorrect or incomplete information, in order to avail the benefit applicable to the OCI/PIO card holders, then such a candidate shall be excluded from all admission processes. In case such a candidate has already been given admission, the admission shall stand cancelled.

**23.17** Note that there will be no spot admission rounds in IITs (Indian Institutes of Technology), after completing the counselling. IIITDM Jabalpur (Indian Institute of Information Technology, Design and Manufacturing) may conduct a spot round of admissions at the institutional level if there are any vacant seats after completion of the counselling.

## 24. APPLICATION FORM FOR ADMISSION

**24.1** Only UCEED 2026 qualified students can apply for admission to the BDes programme at IIT Bombay, IIT Delhi, IIT Guwahati, IIT Hyderabad, IIT Indore, IIT Roorkee and IIITDM Jabalpur for the academic year 2026-2027. There will be a common application form for admissions to respective BDes programmes. The UCEED Office, IIT Bombay, will process the common application form and conduct the joint seat allocation process.

**24.2** The common application form will be available through the IIT Bombay Admissions Portal. The link for the same shall be available on the official UCEED website ([www.uceed.iitb.ac.in](http://www.uceed.iitb.ac.in)). Applicants can fill in their personal particulars and select institutes of their choice by indicating the order of preference.

**24.3** The application can be submitted after paying the application processing fee, uploading digital copies of relevant supporting documents, and the signed copy of the completed application form. The online application form provides detailed instructions on each step of the application process.

**24.4** Supporting documents required for application are digital copies of photograph, signature, UCEED Score Card, qualifying examination Mark Sheet (Class XII or equivalent), and where applicable, EWS/OBC-NCL/SC/ST Certificate, PwD Certificate, and OCI/PIO Card.

**24.5** UCEED and BDes admissions are two different activities. The category-wise rank obtained in UCEED indicates the candidate's position in the respective category at the time of the result declaration.

**24.6** Seat allocation will be based on the All-India Rank (merit order), reservation category and seat availability in each institute at the time of seat allocation.

**24.7** Applicants will be able to edit their application form, including the order of preference of institutes and resubmit it till the closing date of the application period. However, after the closing date, all institute choices and information filled in the applications are treated as FINAL. Requests for ANY changes in the application (after the closing date) will strictly NOT be entertained.

**24.8** It will be the sole responsibility of the candidate to provide the correct and complete information regarding the qualifying exam and category and upload the correct documents in the required formats in the application form. Application forms that are incorrect and/or incomplete in any way will be summarily rejected, and the

application will be considered invalid. The admitting institutes will conduct a document verification exercise for each candidate during admission. The admitting institutes have the right to cancel, at any stage, the admission of a candidate per their rules and regulations in practice if it is found that any information provided by the candidate is incorrect or the application is incomplete.

**24.9** Candidates may note that the offer of admission made to them during the online seat allocation process is provisional and will be confirmed by the admitting institutes only after the requisite fees are paid, the documents are duly verified, and their formalities are completed. Once the counselling is closed, the entire process of BDes admissions through the UCEED office is considered to be over and no further changes (viz. changing institute etc.) are permitted.

## 25. APPLICATION FEE

The BDes admission application counselling processing fee for applicants of all categories and genders is ₹ 4,000/- (Rupees Four Thousand only). This fee is **non-refundable and non-transferable**.

## 26. SEAT ALLOTMENT

FIVE rounds of seat allotment will be conducted. The schedule for the seat allotment rounds is given below. However, the seat allotment will be closed once the seats are filled. A seat will be provisionally allotted based on the applicant's All India Rank (AIR) in UCEED 2026, category and choice of institutes. Selected candidates will be sent provisional allotment letters via their registered email. They will be directed to an online payment system to remit the Seat Acceptance Fee of ₹ 60,000/- (Rupees Sixty Thousand only) for GEN/EWS/OBC-NCL and ₹ 15,000/- (Rupees Fifteen Thousand only) for SC/ST/PwD.

The following rules will govern the joint seat allotment:

- 26.1** If the selected candidates DO NOT remit the seat acceptance fee before the deadline or DECLINE the admission, their application will stand CANCELLED.
  - They will NOT be considered for the subsequent round of seat allotment.
  - These vacant seats will be offered to other eligible candidates to be filled up during the subsequent rounds (if any) of seat allotment.
- 26.2** If applicants are allotted their FIRST choice of institute, they can either ACCEPT ('freeze') the offer or DECLINE it. If they choose to DECLINE the offer, they will NOT be considered for subsequent rounds, and their current seat allocation shall be CANCELLED. This seat will be filled during the subsequent rounds (if any) of allotment.

**26.3** Suppose applicants are allotted their SECOND/THIRD/FOURTH/FIFTH choice of institute. In that case, they can opt to either ACCEPT ('freeze') the choice or ACCEPT WITH THE OPTION TO BE CONSIDERED FOR UPWARD MOVEMENT ('float') choice for subsequent rounds (if any) of the joint seat allocation.

- If the candidates choose the 'freeze' option, it means they have ACCEPTED the offer and do not wish to participate in further rounds of seat allocation. Such candidates will NOT be considered in subsequent round(s) of seat allocation.
- If the candidates choose 'float' option, it means they have ACCEPTED the offer and have indicated that, if admission to an institute of their higher preference is offered, they will accept it. Else, they will continue with the currently accepted institute. Such candidates will be considered in subsequent round(s) of seat allocation.
  - For candidates who choose the 'float' option, allocation of a seat in an institute of their higher preference in a subsequent round would AUTOMATICALLY result in the forfeiture of the seat accepted by them in the earlier round.

**26.4** In cases of ACCEPT/FLOAT/FREEZE, the candidates must pay the complete amount of the seat acceptance fee mentioned in the provisional seat allotment letter. Failure to make the payment will result in the cancellation of their allotted seat, and they will not be considered in any further rounds (if any) of seat allocation.

**26.5** Candidates offered seats have to remit the seat acceptance fee only ONCE. Thus, candidates allotted another seat (because they chose the 'float' option) need not pay the seat acceptance fee again. Candidates must exercise extreme caution and avoid getting tricked by fraudsters contacting them regarding rank allotment and admissions. Please follow information provided on the UCEED website ([www.uceed.iitb.ac.in](http://www.uceed.iitb.ac.in)) only.

**26.6** For candidates who accept the offered seat, the seat acceptance fee will be adjusted against the institute fees of the admitting institute at the time of joining. For candidates who decline the offered seat after remitting the seat acceptance fee, the refund of the seat acceptance fee will be governed by the policies of the admitting institute.

**26.7** To avoid any last-minute unforeseen transaction issues, **candidates are advised to pay the Seat Acceptance Fee for a round well before the end time/date of the corresponding round.**

**26.8 All candidates, who will pay the Seat Acceptance Fee in rounds I and II, can withdraw till the round-II withdrawal end date for claiming the refund.** Withdrawals can be done only during the prescribed withdrawal schedules. The refund will be ₹ 55,000/- (Rupees Fifty-Five Thousand only) for GEN/EWS/OBC-NCL candidates, and ₹ 10,000/- (Rupees Ten Thousand only) for SC/ST/PwD candidates, after deducting the seat cancellation and processing charges of ₹ 5,000/- (Rupees Five Thousand only).

**26.9** Seat Allotment Rounds III, IV and V are for filling of the vacant seats, if any. The option “FLOAT” will remain ACTIVE till the payment end date of Round-IV. **Candidates can withdraw during the prescribed withdrawal schedules for Rounds III and IV but Seat Acceptance Fees paid in the Rounds III, IV and V will not be refunded.**

**26.10** Candidates do not have an option to withdraw/decline an accepted/allotted seat after the announcement of the last round of seat allocation.

## 27. FEE STRUCTURE


